

2. 審査結果の要旨 (1,000 文字以内) Summary of examination results

The reviewers are requested to describe the results of the examination (pass/fail) and a summary of the evaluation within approximately 1,000 words. Please note that the last part of the summary should be the following, in order to use the passages as the manuscript for the "abstract of the contents of the doctoral dissertation and the summary of the results of the examination" when the university publishes the dissertation on its website according to the MEXT instructions.

The dissertation examination was conducted on 2022.01.13 in the presence of three faculty committee members, and attendance by several other GSPH faculty and students. The Zoom platform was used in which Dr. Murano presented from a room on campus (CCA) and others attended through Zoom. The presentation lasted for approximately 25 minutes and open Q&A last for about 30 minutes. Dr. Murano provided a clear, thoughtful, and coherent presentation of her dissertation research which comprised addressing multiple aims in line with the caliber of research we would expect of a doctoral student. Her topic regarding IUGR is timely and important given the prevalent nature of this phenomenon in Japan and its effects on perinatal outcomes. With pre-pregnancy BMI and pregnancy weight gain standards being very different in Japan compared to other developed countries, Dr. Murano's research utilizing the large Japan Environment and Children Study can be seen as contributing important evidence to the literature in general, as well serving as a basis for real movement on this issue in Japan. As a clinician and researcher, Dr. Murano intends to continue her research efforts on this topic with the aim of triggering change at the practice level. In a closed session with Dr. Murano, the committee members questioned and commented on several aspects of the dissertation including methodological details and the implications and next steps of this work. Dr. Murano was appropriately responsive to the questions, and after offering a two week period to address the comments in a revised dissertation, the committee has determined that her final submission meets the quality and standards of dissertation work of the graduate program in public health. The dissertation has not yet been published; however, upon confirmation by the dissertation supervisor, manuscript submission will occur in the near-term.

Based on the foregoing, the dissertation is worthy of the award of the degree of Doctor of Public Health as stipulated in Article 6 of the Academic Degree Regulations of the University, and the applicant is recognized as possessing the advanced research abilities and abundant knowledge necessary to independently conduct research activities in public health, and is judged to have passed the dissertation examination and the final examination.
